TERM OF REFERENCE

HIGH LEVEL LEADERS MEETING (HLLM) ON "GLOBAL MULTI-STAKEHOLDER COLLABORATION TO ACHIEVE SAFE, PEACE AND HARMONY IN CYBERSPACE TOWARD SOCIAL ECONOMIC DEVELOPMENT"

BALI, OCTOBER 21ST 2013

1. Background

Recalling the last two Ministerial Meetings in Nairobi, Kenya 2011 and Baku, Azerbaijan 2012, as a Pre-IGF Meetings, it is recognized that all stakeholders have a similar vision in which Internet plays a very significant role in promoting human well being, economic and social development. We, moreover, consider the urgency to develop a safe and secure global cyberspace. In this regards, at the 8th Internet Governance Forum (IGF) meeting 2013 in Bali, the Government of Indonesia proposes "Global Multi-Stakeholder Collaboration to Achieve Safe, Peace and Harmony in Cyberspace toward Social Economic Development" as the theme for HLLM in the Pre-IGF 2013.

We are fully aware that nowadays all Internet communities have a common perception and concern in building safe, peace and harmony in cyberspace toward social economic development. We require an in depth discussion of those perception and concern by involving internet stakeholders to initiate a global action. It would be cumbersome and practically futile for each individual stakeholder to face these challenges individually. Therefore, we altogether need to act and to establish common values to build a safe, peace and harmony in cyberspace based on cyber ethics principles toward social economic development that can be adopted at the national, regional and international level.

It is recognized that the internet has given effects far beyond its functional uses and initial purposes. Internet becomes more embedded in human life among social members. These effects pose increasingly significant ethical challenges and create social implication and consequences. The difficulties to determine borders and jurisdiction of state in cyberspace shall not undermine the fact that each country has its respective interest that should be taken into consideration by other countries. The ceaseless attempts made by countries in international fora to establish common or global platforms reflect the necessity to harmonize national laws. Therefore, we must be able to anticipate and address these challenges

complementary to the implementation of laws and regulations that needs multi dimensional approach through collaboration among multi-stakeholders.

Affirming as a multi-stakeholders forum, represented by governments, private sectors, academia, and civil society, IGF has a significant role in building information society and developing a safe cyberspace. IGF as part of one global community has responsibilities to foster sustainability, robustness, stability and development of the Internet based on universal values and mutual cooperation.

Considering the multidimensional approach in governing cyberspace, it is the right moment for us to put on the table the urgency for cyber ethics discussions. These cyber ethics become a guidance to foster harmonization of information society that contributes to the sustainability, stability and robustness of the cyberspace.

Therefore, Indonesia proposes that we, as one global community, need to develop a more concrete global cyber ethics principles based on mutual respect of interests. These principles will become a common reference for all stakeholders to build safe, peace and harmonious society in cyberspace toward economic prosperity. Strong commitment from all stakeholders to declare cyber ethics would enhance our efforts to pursue this goal.

Based on the above and various other pertinent considerations, it is relevant and important for us to discuss in this forum the theme of "GLOBAL MULTI-STAKEHOLDER CYBER ETHICS PRINCIPLES TO ACHIEVE SAFE, PEACE AND HARMONY IN CYBERSPACE TOWARD SOCIAL ECONOMIC DEVELOPMENT" to have a common understanding on the urgency of establishing cyber ethics principles. At the end of these discussions, it is proposed that this movement can be realized in some sort of declaration called "BALI DECLARATION OF CYBER ETHICS PRINCIPLES".

2. Scope

The scope of the HLLM is to discuss and develop Bali Declaration of Cyber Ethics Principles as guidance for multi-stakeholders that could be implemented in their policies and governances without impairing, contradicting, restricting or derogating from any relevant international or regional consensus and national interest. These principles are built and referred to universal values such as freedom, equality, solidarity, tolerance, and shared responsibility, as common reference to pursue safe, peace and harmony in cyberspace toward economic prosperity.

3. Objectives

The objectives of this meeting are to:

- a. Formulate the **BALI DECLARATION OF CYBER ETHICS PRINCIPLES** that could be implemented by people around the world within all cultures and religions, not as a replacement for their beliefs, but as an acceptance of global ethics in cyberspace.
- b. Declare the **BALI DECLARATION OF CYBER ETHICS PRINCIPLES** to achieve safe, peace, and harmony in cyberspace toward economic prosperity.

In carrying out these objectives, the HLLM may analyze other aspects related to the objectives such as frameworks that support an optimal Internet development and to provide a safe, peace and harmony in cyberspace.

6. Deliverables

This meeting will deliver a document called **BALI DECLARATION OF CYBER ETHICS PRINCIPLES**.

7. Approval of deliverables

The Meeting will follow a consensual process.
