Also annexed is a draft agenda for the Meeting adopted by the Permanent Executive Committee (COM/CITEL) at its XXVI Meeting, and a draft schedule. **December 10, 2013** is the period for the Member States to present observations on that draft agenda to the Chair of COM/CITEL (Article 9 of the Statute; Article 28 of the Regulations).

We also annex information on: participation, elections, and voting.

On February 10, 2014, the "Strategic Dialogue on Broadband and Internet Development in the Americas" will be held. The objective of the Strategic Dialogue preceding the VI Assembly of CITEL is to bring together senior government officials responsible for telecommunications and ICTs, the private sector, experts from the Internet technical community, and representatives of international organizations, civil society and academia, to exchange information, best practices, views and perspectives on the status and future development of Broadband and the Internet in the Americas region, including capacity building and human resource development.

The Strategic Dialogue will focus on policy, regulatory, technical, economic and capacity building issues associated with broadband infrastructure deployment and use, Internet development, mobile applications and content for social and economic development, and on regulatory frameworks to promote competition, investment and public-private partnerships.

After the Assembly, on February 13, 2014, the XXVIII Meeting of the Permanent Executive Committee of CITEL (COM/CITEL) will be held.

Participation

Note that this Meeting is open to the OAS member states, observers, and guests (Article 7 of the Statute) as provided in the Statute and Regulations of CITEL. We wish to advise that active associate members of the Permanent Consultative Committees of CITEL may participate in the event as observers. (Article 17 of the Regulations)

The Secretariat of CITEL would be grateful if you would forward to us, by **January 10, 2014**, the list of members of the delegation that will represent your member state, permanent observer mission to the OAS, or associate member of CITEL at this event. Also please note that, at the time of the Meeting, the member state delegations must present the corresponding credentials from their governments (Article 11 of

the Regulations). It is suggested that the Administrations include in their delegations to the Assembly the highest-level authorities of the telecommunication sector of their respective countries, as deemed advisable. **December 10, 2013** is the period for receipt of requests to participate as an Observer in the Meeting of the Assembly. These requests must be made in writing to the Chair of COM/CITEL. (Article 18 of the Regulations)

Documents

Lastly, we would be extremely grateful if you would forward to this Secretariat reports and proposals for the Assembly by January 24, 2014 (Articles 30 and 31 of the Regulations) so that they can be distributed to the Member States in the working languages of CITEL. Documents not submitted by this deadline will be presented at the informal meeting of Heads of Delegation for a decision as to whether they will be considered at the meeting as informative documents or as proposals. All delegates are invited to consult/download the meeting documents prior to the meeting date, utilizing the Collaborative Space of CITEL, and to print them as required. Contributions submitted as informative documents will not have priority for translation and the Secretariat of CITEL recommends that translations be forwarded, or, for lengthy documents, summary, rather than full, translations may be accepted.

We also wish to advise that wireless network equipment will be in operation, so that documents will be accessible in the meeting rooms for those with a personal computer with a Wi-Fi compatible 802.11b/g wireless card. In view of the available wireless network and existing budgetary restrictions, hard copies of documents will not be available and orders of business will be distributed electronically.
