

INTERNET GOVERNANCE CAPACITY BUILDING PROGRAMME

PARTICIPANTS AND SELECTION PROCESS

March - October 2007



INTRODUCTION

The call for participants for the 2007 Internet Governance Capacity Building Programme was sent out on 15 January 2006. Over a period of three weeks, 570 valid applications were received. The selection process, which involved a team of ten persons (six Programme Supervisors plus four Diplo team members), resulted in the selection of 138 participants, who were then divided into 8 regional groups of 15-16 participants each.

In response to requests made by previous years' participants from Latin America, we have also put together a Spanish/English bilingual group of participants mainly from the Latin American region. This group will be supervised by two bilingual Spanish-speaking facilitators.

138 participants have confirmed their participation to attend the programme, consisting of the online course stage (March -June 2007) and research project stage (July-September 2007).

NOTE: The text and data in the enclosed document were copied directly from the application forms and were not edited.

SELECTION PROCESS

Over a period of three weeks, since the Programme was first announced, we received **570 valid applications from 100 countries of which 92 were from developing countries**. From all of these applications, we had to select 138 participants, which were divided into 8 regional groups, with an additional Spanish bilingual group that has been formed in response to demand.

The selection process was a group exercise, involving facilitators and lecturers. Our facilitators and lecturers evaluated the applications according to the following criteria:

- academic background;
- professional experience;
- regional participation;
- gender;
- stakeholder participation.

Two types of evaluations, numeric and descriptive, were used to compile a final list of 138 selected participants, with 65 participants being placed on a waiting list (in the case of cancellation or weak performance over the first two weeks of some of the participants).
