3	Access	Daniel Stern	 Daniel Stern has played a role in the promotion of ICT4D in Uganda, and to a lesser extent Tanzania, Rwanda and Kenya in his capacity as director for his NGO, UConnect. His organisation was implementing partner on the ITU, UNESCO and IDRC Multipurpose Community Telecentres project in 1997. His organisation has provided training and pioneered the use of several Internet technologies in the region, including VHF data for the WFP's DFMS+ network. He helped to lead the Uganda IXP project at a critical juncture, have organized the training of hundreds of government officials in use of ICTs. He has advocated for discount Internet for schools and espoused the opening of schools computer labs to parents and community out of school hours for schools-based community Internet Training Centres, otherwise known as telecentres. On another front he is a member of the Advisory Board for Ink-Media, and hopes to play a role in the distribution of a low-cost ultra-low energy laptop that, together with newly emerging inexpensive portable nanotechnology-enabled thin film photo voltaic devices and the now almost ubiquitous (in Uganda and some other countries) and relatively inexpensive GPRS Internet, will make ICTs accessible to vast numbers of people in rural areas of developing countries.
