Reports of the Fifth Committee

The Rapporteur of the Fifth Committee introduced the reports of the Committee on agenda items 130, 132, 138, 141 and 142.

Under rule 66 of the rules of procedure, the General Assembly decided not to discuss the reports of the Fifth Committee which were before the Assembly.

The General Assembly adopted the draft resolution recommended by the Fifth Committee in paragraph 6 of its report (A/64/596/Add.1) (resolution 64/259).

The General Assembly thus concluded this stage of its consideration of agenda item 130.

The General Assembly proceeded to take action on draft resolutions I and II recommended by the Fifth Committee in paragraph 8 of its report (A/64/548/Add.2), as follows:
