Director – CDT Brussels

The Center for Democracy & Technology is seeking a senior legal or policy professional to establish and lead its new Brussels office. This job offers a rare and exciting opportunity to shape public policy on key issues of the digital age

The Director of CDT's Brussels office will be responsible for coordinating CDT's advocacy in the European Union on all of CDT's substantive project areas. Key goals for the Director of CDT Brussels will include fostering multi-stakeholder dialogue on key issues, promoting policy solutions that support an open and innovative Internet, and encouraging better mutual understanding between the EU and the US on Internet policy issues.

RESPONSIBILITIES:

The responsibilities of the Director of CDT's Brussels office will include:

- Strategic planning and management of CDT's Brussels office;
- Legal and policy analysis and development of policy recommendations related to EU proposals affecting the open Internet and digital rights, in close collaboration with CDT Project Directors;
- Outreach to relevant stakeholders, including the technology sector; civil society; academics; and technologists;
- Development and coordination of multistakeholder working groups, consultations, and convenings in Brussels;
- Representation of CDT before EU bodies; may also involve representation before national governments and regional or international governance bodies;
- Public education, media and public speaking; and
- Policy and technical assistance to policymakers, regulators, and stakeholders.

QUALIFICATIONS:

This position is designed for candidates with significant experience. An ideal candidate would have –

- An advanced degree in law, public policy or other relevant field;
- A minimum of 5 10 years in relevant legal or policy positions with increasing levels of responsibility and project management experience;
- Comprehensive knowledge of the complex policy areas and key issues relating to the online environment;
- Excellent verbal and written communication skills;
- Fluency in English required. Fluency in additional European languages preferred;
- Experience with EU institutions and policymaking processes;

- Basic understanding of Internet technologies; advanced knowledge of technology and/or technical standards and work with technical standards bodies would be a plus;
- Demonstrated project planning and organizational skills;
- Demonstrated ability to manage diverse coalitions;
- Commitment to CDT's mission; and
- An entrepreneurial and collaborative working style.
