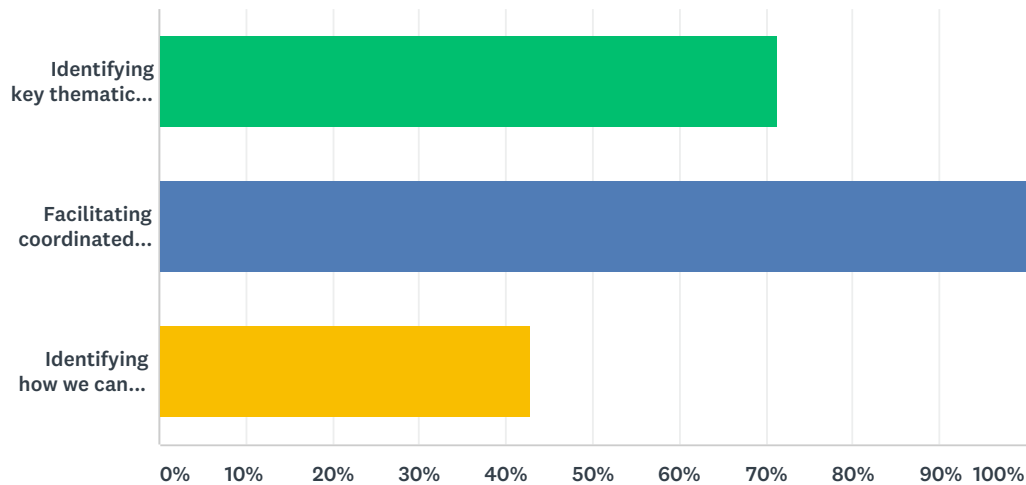


Q1 What do you think should be the key focus for the IGC over the period November 2019-November 2020?

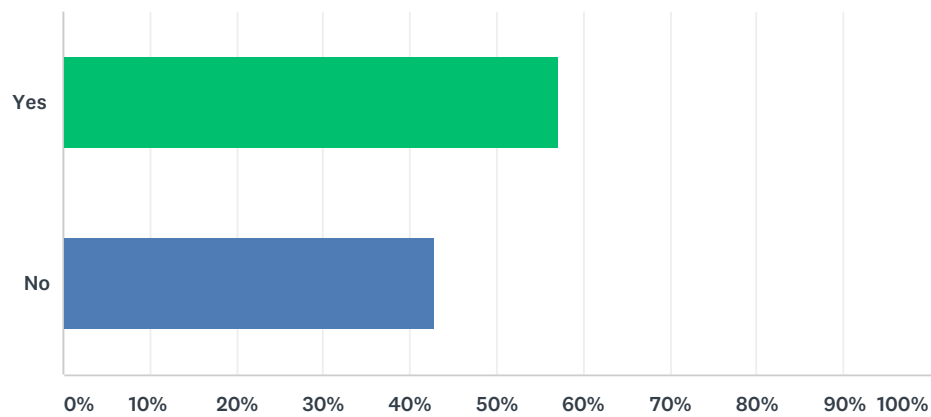

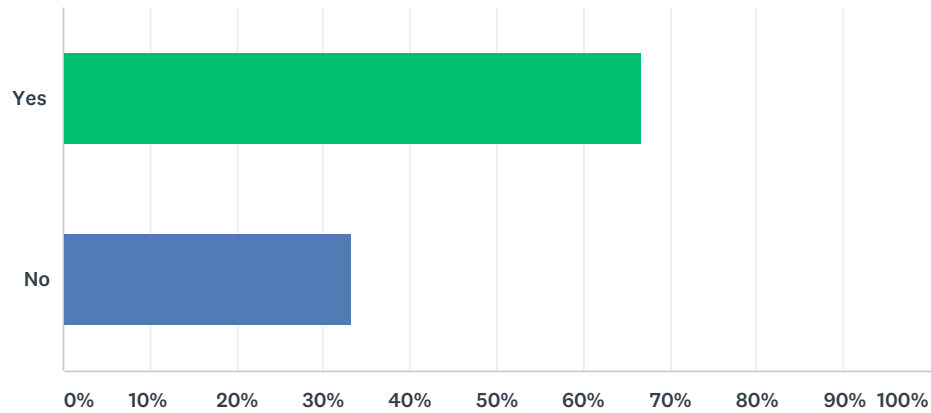

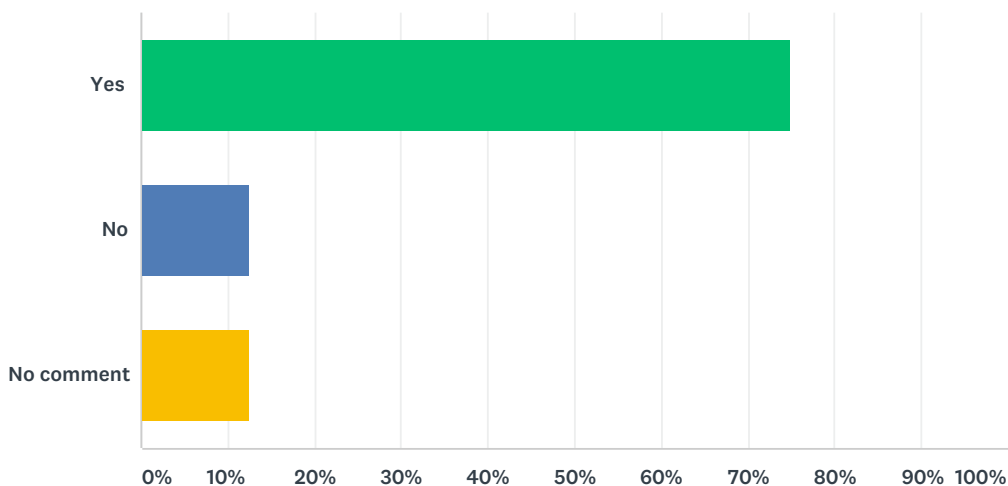

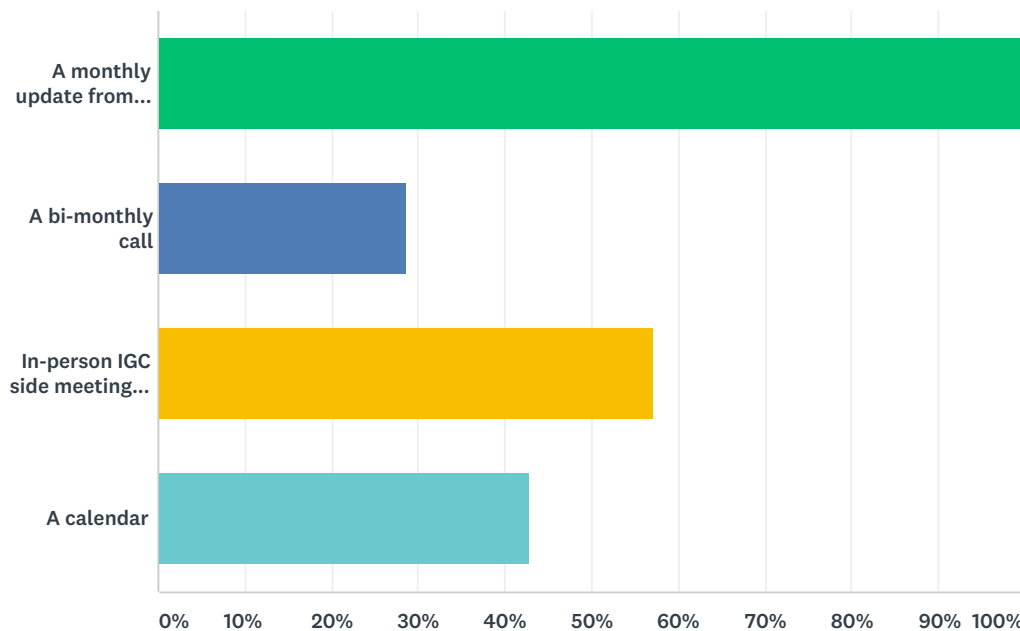
